He wrote to us concerning NH3 slip measurements: in the Euro VI Regulation, the limits for NH3 (Ammonia) is 10 ppm. No figures for resolution or overall accuracy are quoted, but a resolution of 1% of the limit value, i.e. 0,1 ppm, would seem unreasonable. Should we try to establish the requirements for accuracy and for resolution during the legislative process? Should EGEA discuss a measurement procedure (in-situ vs. extraction)?
