1. Opening and welcome

5.1. Introduction of the participants

The participants and UNISYS introduced themselves (see "Unisys business cards.jpg" attached).

5.2. Update on the status of the VIP project

UNISYS had difficulties to understand the interest of the different stakeholders. Spain and Netherlands centralized. Belgium is decentralized. Data privacy is important. Which data can be possibly exchanged or centralized. UNISYS is mainly concerned about the exchange of information between Member States and not inside a Member State. Spain will help UNISYS to set up the questionnaire. A pilot interview will then follow in the Netherlands. Interesting: encryption, network system, data privacy, future needs, what kind of information is needed. A lot of stakeholders need to be contacted.

5.3. Review of the questionnaire to be sent to the Member States UNISYS is finalizing the questionnaire for the member states and other stakeholders (e.g. vehicle registration authorities), to understand how the Member States are organized.

5.4. Review of the list of questions to the European Commission Marco Le Brun presented the list of questions to UNISYS. Some clarifications were made. Please refer to attached "EGEA WG10 4th meeting V3.pdf".

It was decided first to review the use cases, before deciding.

The business model has been modified to reflect the current understanding in the group (see page 7 of the attached "EGEA WG10 4th meeting V3.pdf").
