# Draft Agenda (Rev01)

On the basis of the Ricardo-AEA report, the EU Commission is currently preparing a report to the European Parliament and the Council on the functioning of the Euro 5 - RMI provisions. This is why we would like to assess with you the Ricardo-AEA report (is the fact-finding correct?) and collect suggestions from your side on how to improve the Euro 5 Regulation (remedies, eg a European ETI?). The aim is to submit our proposals to the Commission.

- b) As further preparation, we ask you to please read the sections 3.2.2. and 5.3 and 5.6.3 of the Ricardo-AEA report, which concern diagnostic tool manufacturers.
