# To Annex F

Mr. Greupner reports that he was in the German institute IFA to discuss Annex F of EN 1493 in comparison to the requirement on remote controls for cranes. The result was that both requirements are on the same safety level.

During the discussion in the WG the following question arises:

The headline of Annex F reads "Additional requirements for cableless controls and control systems". The question is, whether this Annex is also valid for e.g. bluetooth data transfer between the columns of a mobile column lift.

Mr. Trabold will clarify this with the IFA, maybe that the headline of Annex F then will be changed.
